Members shall register to attend, or appoint a Proxy, by no later than 15:00 hrs on Wednesday, 18<sup>th</sup> August 2021.

To approve the appointment of Mile and Associates to hold office as the Auditors of the Institute for the year 2021 at a remuneration of MVR 19,875 (inclusive of GST).

The Council of the Institute has approved the appointment of Mile and Associates and requests the members approval for the appointment of Mile and Associates as the External Auditors of the Institute for the year 2021.

## **2. Queries on AGM**

If a member has a query regarding any matter relating to the AGM, we ask members to email the queries to [info@camaldives.org](mailto:info@camaldives.org), no later than 15:00 hrs on Wednesday, 18<sup>th</sup> August 2021, along with your full name and NIC number. The Institute will be accepting queries from members and proxy holders who are registered to attend the AGM.

During the event, a messaging option will be activated for members and proxy holders to submit their questions and queries for each item on the Agenda.

## **3. Members eligible to attend the AGM**

Persons registered as an Associate or Fellow Member of the Institute as of Wednesday, 11<sup>th</sup> August 2021 are eligible to attend and vote at the AGM.

## **4. Registration**

Registration for AGM will be open for members starting from 16:00 hrs Wednesday, 11<sup>th</sup> August 2021. Eligible members are requested to register their attendance through the Institute's member portal (<https://portal.camaldives.org/>) by no later than 15:00 hrs on Wednesday, 18<sup>th</sup> August 2021.

Members are required to ensure that their registration is complete before the given deadline.

Upon completing the registration, registered attendees will receive an email from the Institute confirming their registration for the AGM.

## **5. Proxy Registration**

A member who is entitled to attend and vote at the AGM can participate virtually in person or appoint 1 (one) proxy to participate virtually and vote in place of that member. The proxy holder must be over the age of 18, of sound mind, and able to vote on behalf of the member. Proxy holder

is only entitled to one vote on behalf of the member represented by him/her. The proxy need not be a member of the Institute.

The Institute may (but shall not be under any obligation) to call members to verify the appointment of a proxy.

Members who wish to appoint a proxy to attend the AGM on their behalf may do so no later than 15:00 hrs on Wednesday, 18<sup>th</sup> August 2021. Proxy registration option will be available in the member portal. Members are encouraged to ensure that proxy information entered during registration is correct.

Member registrations and Proxy registrations which are incomplete, illegible, unclear or do not contain all the required information may be rejected at the discretion of the Institute.

Upon completing the registration, member and proxy will receive an email from the Institute confirming the registration for the AGM.

## **6. Proxy Revocation**

Any member who has appointed a proxy can thereafter attend the AGM in person only if the proxy has been revoked. The appointed proxy can be revoked by submitting an email requesting for proxy revocation by no later than 15:00 hrs on Wednesday, 18<sup>th</sup> August 2021. The request should be sent by e-mail to [info@camaldives.org](mailto:info@camaldives.org).

The Institute may (but shall not be under any obligation) to call members to verify the revocation of a proxy.

All members of the Institute as of 15:00 hrs on Wednesday, 11<sup>th</sup> August 2021 are eligible to attend the AGM in person or by proxy and participate and vote in person or by proxy. Each member who is present in person (or by proxy) shall have 1 (one) vote per Agenda Item.
